- Monitor patients remotely via a secure Telehealth platform and FDA-approved medical sensor devices. Telehealth visits can be billed directly through the platform using billable remote patient monitoring CPT and Z codes.

Our patient-centered approach enables individuals to connect with their entire care team, have a holistic view of their health information, and become active participants in their healthcare through a single platform.

Providers also have access to a more complete health record of their patients, telehealth capabilities to meet patients virtually, and the potential to generate additional revenue for their practice.
